

MGI+MORE Privacy Policy

This privacy policy explains how MGI Plus More (Auckland) Limited (MGI+MORE) may collect, store, use, and disclose any personal information that you provide when using the MGI+MORE website (www.mgiplusmore.co.nz). Your use of the MGI+MORE website provides your unconditional consent to us collecting, storing, using, and disclosing your personal information in the manner set out below. This privacy policy is subject to, and must be read in conjunction with, the MGI+MORE website terms of engagement. In this privacy policy 'we', 'us', and 'our' refers to MGI+MORE.

Collection

We may collect your personal information (including, without limitation, your name, email address, and phone number) when you use the MGI+MORE website. You may decide not to provide your personal information to us. However, if you do not provide it, we may not be able to provide you with access to certain information or services.

Automated collection

When you visit the MGI+MORE website, we may use automated technology (such as usage monitoring software, cookies, and sessions) to collect and store certain information about your visit. Please see the Cookies for more information.

Cookies

A Cookie is a small portion of data sent from a website and stored in a user's web browser while a user is browsing a website. When the user browses the same website in the future the cookie data can be retrieved by the website to notify the website of the user's previous activity.

We will not sell, rent, or lease your personal information to third parties. Your personal information will be made available internally for the above purposes and we will not disclose your personal information

We will only use or disclose personal information that you have provided to us, or which we have obtained about you:

- c) if we have given you notification of the intended use or disclosure and you have not objected to that use or disclosure;
- d) if we believe that the use or disclosure is reasonably necessary to assist a law enforcement agency or an agency responsible for national security in the performance of their functions;
- e) if we believe that the use or disclosure is reasonably necessary to enforce any legal rights we may have, or is reasonably necessary to protect the rights, property and safety of us, our customers, or others;

or

- f) if we are authorised, required or permitted by law to disclose the information.

Storage and security

Personal information collected on the MGI+MORE Website is collected and held by MGI+MORE. We will take reasonable efforts to protect personal information that is held by us from loss, misuse, unauthorised access, disclosure, alteration, or destruction.
